Dear Chairwoman DeLauro and Ranking Member Cole:

The National School Boards Association (NSBA) greatly appreciates your bipartisan leadership to address our membership's top priorities for education investments in your legislation for Fiscal Year 2020 Labor, Health & Human Services, Education and Related Agencies Appropriations. The increases you have proposed for education will provide much-needed resources to our students and school districts for special education, Title I programs, effective teachers and school leaders, English Language Acquisition, Student Support and Academic Enrichment, school safety, social/emotional learning, and afterschool programs. Your Subcommittee Mark will also strengthen investments in the Impact Aid program that is critical to school districts educating large populations of federally connected students, including those who reside on Native American trust lands and those whose parents serve in the Armed Forces.

NSBA's membership has prioritized the Individuals with Disabilities Education Act (IDEA), along with other critical programs such as Title I, as valuable resources in closing achievement gaps and advancing equity. Your leadership to maximize the effectiveness of these programs among our students and communities is indicative of Congress' commitment to its promise to fund the federal share of investments in IDEA and to raise student achievement among all students. This appropriations bill will help our school districts and parents address the unique needs of students with disabilities. It will enable our school districts to provide more services essential to student success in core subject areas such as mathematics and reading comprehension. Your Subcommittee mark will allow our public schools to provide greater opportunities for student enrichment, parental engagement and professional development for our teachers and school leaders.


